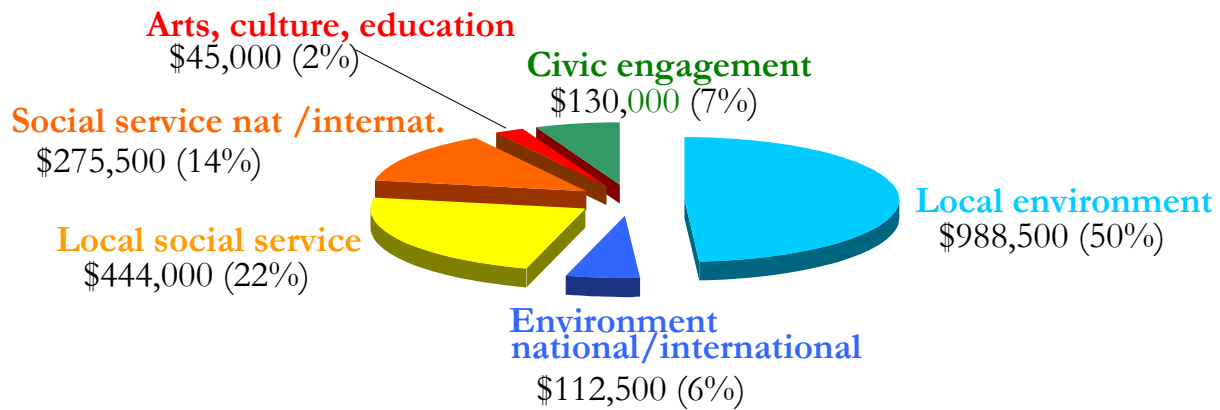


## SUMMARY OF COMMITMENTS IN 2007
