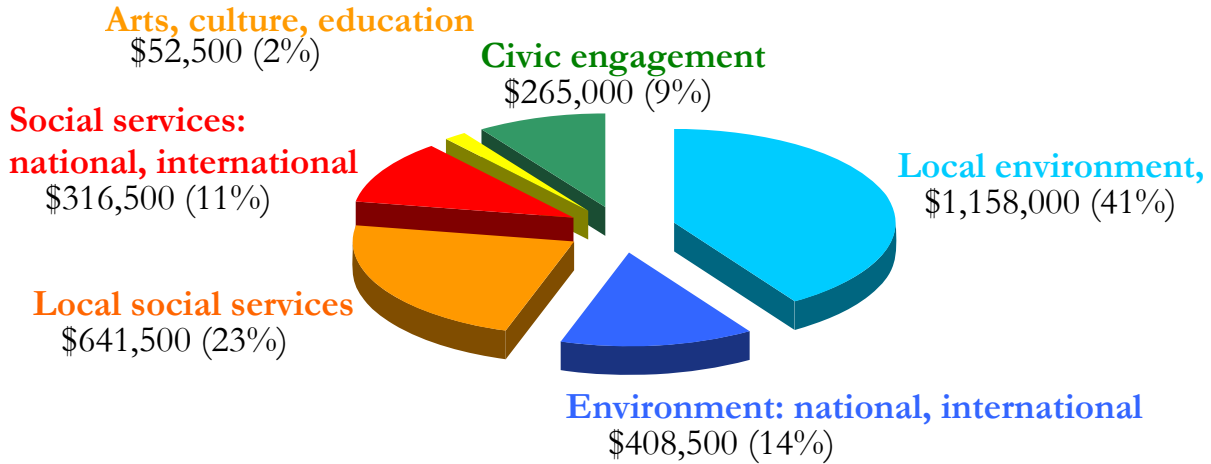


SUMMARY OF COMMITMENTS IN 2008
